- b. Background Checks (looking to consolidate with LL and other organizations) Research on Background Check Companies from Rec Dept. continued discussion
  - Steve Felt made motion to change the wording of the County Ordinance regarding background checks:
    - > The recreation director and/or assistant recreation director or authorized outside background security agency shall review the results of all background checks and (a) shall advise the recreation director of those volunteers who are and who are not qualified under this article; (b) shall, in consultation with and upon the advice of the county attorney, notify all volunteers who are disqualified of their disqualification and the reason therefore; and (c) shall further attempt to rectify any discrepancies in the background check s of volunteers who are apparently disqualified. The county manager shall have the discretion and sole authority to approve volunteers who would otherwise be disqualified for any extenuating circumstances or inequitable results in the application of this article.
